



School Fees Schedule and Information For Academic Year 2026–2027

All fees are quoted in Ringgit Malaysia and exclude any applicable statutory taxes. Fees are reviewed annually and are subject to change. All fees are non-refundable unless indicated.

APPLICATION & ENROLMENT

1. Application fee <i>Payable upon submission of the Application Form</i>	RM1,500
2. Enrolment fee <i>To be paid to confirm the placement of a child</i> <i>Note: For children joining Pre-School and Reception, RM5,000 of the Enrolment Fee is payable to confirm the placement. Upon entering Year 1, an additional RM15,000 is applicable.</i>	RM20,000

MEMBERSHIP IN THE ALICE SMITH SCHOOLS ASSOCIATION

- Parents who wish to have their child admitted to the School as a student must first be admitted as a Parent Member of The Alice Smith Schools Association ("the Association").
- Parents must pay a **membership fee** of **RM20** to join the Association.

SCHOOL FEES

- School fees are billed on a termly basis and are payable by the first day of the term. There are three (3) terms in an academic year.

2. School fees include all books, materials and resources.
3. A parent deposit is required for each child. The deposit is refundable when the child leaves the school with sufficient notification (one full term's notice).
4. A re-entry fee of **RM2,000** is payable upon re-joining for children who have left the School. Children who leave the School before progressing to Year 1 will be subject to an Enrolment Fee of RM15,000 upon re-entry.

DISCOUNT

1. **Sibling Discount** is only applicable to families with three or more children attending the School at the same time.

SALES & SERVICE TAX (SST)

All fees are subject to **6% SST**, in accordance with current Malaysian Government regulations. If you are eligible for an exemption, please provide the necessary documentation to the School's Finance Department at accounts@alice-smith.edu.my.

PAYMENT DETAILS

1. There are three options for the payment of school fees for each academic year:
 - o **Upfront Payment (Full Year):** A one-time payment for the entire academic year. A 3% discount is offered for this option.
 - o **Termly Payments:** Fees are divided into three equal payments, one for each term.
 - o **Monthly Instalment Payment:** Fees are spread out into smaller monthly payments. **Please note:** A 3% surcharge is applied to the total fee amount when choosing this option.
